the said Mr G Everett he the said Septimus Darden by these presents do warrant and forever defend the title of the aforesaid negroes agst the claim or claims of all and every other person or persons whatsoever upon the following trust notwithstanding that the said Mr G Everett shall suffer and permit the said S. Darden to remain in perfect quiet possession of the aforesaid negro slaves until he may be instructed by the aforesd N Francis and then it shall be lawful for him by giving twenty days notice at law or more publick place of the time and place of sale; shall proceed to sell for cash so much or many of the above named slaves as will be sufficient to pay and discharge the debt hereby secured or so much of it as may be then due and all other notes or bonds the said Francis may have executed by S Darden to him subsequent to the date of this Indenture either by his being S Darden by otherwise and out of the proceeds of such sale first pay all reasonable charges attending the sale then pay and discharge the debt hereby secured and all other notes as above stated which may be then due said Francis or so much of them as may be then due him from the said S Darden and lastly if a surplus thereof remain in the hands of S Everett from the sale aforesd that he shall pay the sum over to the said S Darden or to any person authorized by him to receive it As witness our hands and seals this day and date above written

This deed of trust between Septimus Darden of the first part William G Everett of the second part and Nathaniel Francis of the third part was acknowledged by the said Septimus Darden William G Everett and Nathaniel Francis and ordered to be Recorded

This Indenture made and entered into this the 7th day of September 1839 between William Holt and Anne his wife of the County of Southampton of the one part and John M Neale of the same County of the other part. Witnesseth that the said William Holt and Anne his wife in consideration of the sum of eighteen hundred dollars to them in hand paid at or before the enrolling and delivery of these presents the receipt whereof is hereby acknowledged have granted bargained sold and conveyed and by these presents do grant bargain sell and convey unto the said John M Neale his heirs and assigns a certain tract or parcel of land situate in the County aforesaid bounded as follows; To wit: North by the lands of Thomas Mason East by the road leading from Miersons Depot to Marblehead West by the lands of Augusta Pope, and South by Halloway Roville and Lewis Worralls estate Containing one hundred and forty two and one third acres more or less together with the privileges and appurtenances to the said land in any wise appertaining and belonging. To have and to hold the above granted premises to the said John M Neale his heirs and assigns forever. And I the said William Holt for myself my heirs Executors and administrators do covenant with the said John M Neale his heirs and assigns that I and my said wife are lawfully seized in fee of the before granted premises; that they are free from all encumbrances that I and my said wife have a good and perfect right to sell and convey the same to the said John M Neale his heirs and assigns as aforesaid and that I will and my heirs Executors & administrators shall warrant and defend the same to the said John M Neale his heirs and assigns forever against the lawful claims and demands of all persons.
