This Indenture made and entered into on this 1st day of August in the year of our Lord Eighteen hundred and thirty nine between Nathaniel Williams of the County of Southampton and state of Virginia of the one part and George B. Lucy of the same County and state of the other part witness that the said Nathaniel Williams for and consideration of the sum of one hundred dollars current money of the Commonwealth to him in hand paid by the said George B. Lucy at or before the sealing and delivery of these presents the receipt whereof is hereby acknowledged Holt granted bargains and sold and by these presents doth grant bargains and sell unto him the said George B. Lucy his heirs and assigns forever One certain piece or parcel of land situate lying and being in the County of Southampton and parish of Saint Lukes containing thereunto acres be the same more or less and bounded as follows (to wit) Beginning at the fork of the old and new roads in the said Nathaniel Williams and George B. Lucy's line thence the various courses of the old road along said George B. Lucy's line Three hundred and fourtyn poles to the aforesaid new road in the said Nathaniel Williams line thence the new road along said Nathaniel Williams line N 18° W 64 poles thence N 29° W 255 poles to the Beginning to have and to hold the above described piece or parcel of land and premises with all appurtenances thereto belonging or in any wise appertaining unto him the said George B. Lucy his heirs and assigns forever to and for the only purpose we and behalf of him the said George B. Lucy his heirs and assigns forever. And the said Nathaniel Williams further help his heirs Executors and Administrators doth hereby covenant and agree to and with the said George B. Lucy his heirs Executors Administrators and assigns that he will by these presents warrant and forever defend all the right and title of the aforesaid piece or parcel of land and premises against the claims or demands of all and every other person or persons whatsoever.
