 This deed of trust between William D Clarke of the first part Jacob Burnes of the second part and Sally Pope of the third part was acknowledged by the said William D Clarke one of the parties thereto and ordered to be Recorded. And in the Clerk's Office the 18th day of November 1839 the said Indenture was acknowledged by Jacob Burnes one of the parties thereto and ~~acknowledged as aforesaid~~ ^{acknowledged as aforesaid} by Sally Pope the said ~~parties~~ ^{parties} thereto.

This Indenture made and executed this 17th day of October one thousand eight hundred and thirty nine Between Adams Jones and Chasny Jones his wife of the one part and Solomon Johnson of the other part all of the County of Southampton State of Virginia. Witnesseth that the said Adams Jones Chasny his wife have and in consideration of the sum of one hundred and thirty three dollars and thirty eight cents to them in hand paid the receipt whereof Adams Jones is hereby acknowledged bargained and sold alienated and confirmed and by these presents to Solomon Johnson bargained and sold alienated and confirmed unto the said Solomon Johnson his heirs and assigns forever One certain tract and parcel of Land lying and being in Southampton County on the west side of the Road from Hornes to Franklins Containing by Survey Forty eight acres and 2 Roods and is bounded as follows Beginning at a Red Oak along the line of the said Bailey Boyants line thence N 9° E 92 p. along the said Bailey Boyants line to a post Oak thence the said line at 23° E 19 p. to a Red Oak a new corner of this tract and Jordan Boyants thence N 75° E 67 p. along a new line of marked trees between this tract and Jordan Boyants thence S 23° E 66 p. aforesaid a new corner of this tract and Jordan Boyants thence S 23° E 66 p. along the said Road to a white oak a corner of this tract and Bar Brown in Solters line thence up the run of a small Branch along a line of marked trees to a line between this tract and Solters both the various courses shown of 72 p. to a black gum in the said branch thence N 85° W 10 p. to a pine thence S 70° W 15 p. to the Beginning. To have and to hold the above premises with all the revenues and remainders and remainders yearly and other rents forever the said Adams Jones Chasny, ^{his wife} do for themselves their heirs and assigns and assigns warrant and will forever defend the aforesaid premises with all the revenues and remainders and remainders yearly and other rents unto the said Solomon Johnson
