This instrument made and entered into on this 4th day of December in the year of our Lord Eighteen hundred and thirty nine between Jep G. Blew of the first part Thomas B. Morell trustee of the second part and John E. Beale of the third part all of the County of Southampton and State of Virginia witnesseth that whereas the said Jep Blew stands justly indebted unto the said John E. Beale by bond bearing date with these presents for the sum of one hundred and seventy eight dollars 64 per cent this instrument further witnesseth that the said Jep Blew being willing and desirous to secure the payment of the said debt with the interest thereon accruing unto the said John E. Beale together with all costs attending the execution of these presents hath given and in consideration of the sum of one dollar lawful money of Virginia to him in hand paid by the said Thomas B. Morell at or before the sealing and delivery of these presents the receipt whereof is hereby acknowledged given bargained and sold and by these presents doth grant bargain and sell unto him the said Thomas B. Morell his heirs and assigns forever the following property to wit One iron grey mare in bay manure (white face) Eight head cattle forty seven head dogs Forty barrels corn six hogs feather bed steel and furniture two tables & trunk two chest three iron pots four axes 3 great hoes six wood axes two pairs iron wedges hams saw half dozen chains two barrels four ten ploughs hoes three coaltins & four barns and Jack wagon ploughs 1 top stalk and shears three spinning wheels 2 pair cards One pair smooth iron & cast of 4 pair cart wheels To have and to hold the above described property unto him the said Thos B. Morell his heirs and assigns forever and the said Jep Blew for himself his heirs executors and administrators with hourly covenant to and with the said Thos B. Morell his successors attorney and assigns that he will by these presents warrant and defend the right and title of the above mentioned property against the claims or demands of all and every other person or persons whatsoever (Upon trust notwithstanding) to and for the following intents and purposes (viz) that the said Thomas B. Morell or his legal representatives may and shall at any time hereafter when he shall demand requested by either the said Jep Blew or John E. Beale or their representatives sell at public auction for ready money by giving ten days or more previous notice ^{such} of sale all the above mentioned property hereby conveyed or much thereof as may be sufficient to pay and satisfy the aforesaid debt of one hundred and seventy eight dollars 64 per cent with the interest thereon accruing and all costs attending the execution of these presents and out of the proceeds of such sale after paying all costs as aforesaid pay unto him the said John E. Beale his executors administrators or assigns the aforesaid sum of one hundred and seventy eight dollars 64 per cent with the legal interest thereon accruing and the surplus if any pay unto him the said Jep Blew his legal executors or assigns.
