 acknowledge themselves fully satisfied and paid hath granted bargained sold unto the said Gilbert
 V. Vick one certain tract or parcel of Land lying and being in the County aforesaid containing by a
 late survey Just two acres be the same more or less and bounded as follows to wit on the East by the
 land of Robert Wick on the South by the land of James Bell on the West by the land of Gilbert V. Vick
 on the North by the lands of the same together with all ^{houses} out houses yards Gardens Orchards
 Ways water and water courses &c. whatsoever belonging in any wise appertaining. To have and to
 hold the said Land to him the said Gilbert V. Vick to him and his heirs forever and the said James
 Vick and Delilah his wife doth warrant and defend by their presents any person claiming or
