State of Virginia. Whereas that the said Benmitt P Stephenson for and in consideration of one hundred and twenty two and
a half dollars lawful money of Virginia to him in hand paid at or before the sealing and delivery of these presents
the receipt of which is hereby acknowledged by the said Benmitt P Stephenson has bargained and sold and by
these presents does bargain and sell unto the said Allen Stephenson his heirs and assigns forever one certain tract
or body of land with its appurtenances situate lying and being in the County of Southampton containing
by recent survey Sixty five and One fourth acres and bounded as follows. South east by a branch separating this
land from the lands of Docracy Branch and Allen Stephenson North west by the lands of Benmitt Stephenson
and North East by the lightwood Swamp together with the appurtenances thereto to have and to hold
the said land with its appurtenances unto the said Allen Stephenson his heirs and assigns forever. And
the said Benmitt P Stephenson for himself his heirs &c the said tract of Land with all and singular the
promises & appurtenances unto the said Allen Stephenson his heirs and assigns free from the claims or claims of
the said Benmitt P Stephenson and his heirs and of all and every person or persons whatsoever shall well and do

been compelled to give bond in the sum of one hundred and forty dollars with the said John A Hill of John Warren
as security for the payment of the same for which sum the said Benmitt P Stephenson is willing and desirous
to secure. Now this Indenture Whereas that for and in consideration of the promises and also for the further con-
sideration of the sum of One dollar to the said Benmitt P Stephenson (the debtor) in hand paid by the said
Edmon W Shields (the trustee) at or before the sealing and delivery of these presents the receipt whereof is hereby ack-
nowledged by the said Benmitt P Stephenson heath given granted bargained and sold and by these presents doth give
grant bargain and sell release and confirm to the said Edmon W Shields his heirs and assigns forever all that tract
or parcel of Land lying and being in the County of Southampton containing by estimation One hundred acres or
the sum more or less and bounded by the lands of Shadrack Boykin Mt Branch, Ethelbert Branch John Warren
Allen Stephenson, Docracy Branch and the seacock Swamp refferring thereto lying had with more fully appear-
with all and singular the appurtenances unto the said tract or parcel of Land belonging or in any wise appur-
tenant to the same or any part thereof. To have and to hold the said tract or parcel of Land with the appur-
tenances thereto belonging unto the said Edmon W Shields Trustee his heirs executors and assigns forever
and the said Benmitt P Stephenson for himself his heirs executors & administrators with hereby covenant
