Williams test This Indenture made this eighth day of February in the year of our Lord one thousand eight hundred and
 forty between Mills L Gray of the first part, John L Roche of the second part, and Jacob Williams of the third part
 to Roche all of the County of Southampton in the State of Virginia Whereas the said John L Roche on the 1st day of
 in the year of our Lord one thousand eight hundred and thirty eight in order to secure the payment of the
 sum of Five hundred and sixty seven dollars & 75/100 to the said Jacob Williams did by Indenture of last of
 that date convey to the said Mills L Gray his heirs &c. a certain tract of Land lying in the County of Southampton
 joining the lands of Wm. A. Nicholson Mills Pope & Ben^d Edwards Est. containing one hundred and
 thirtion & 2/3 acres being the land on which the said Roche then lived upon trust for the use and behoof
 in the said Indenture mentioned: And whereas since the executing and delivery of the said deed of conveyance
 the said John L Roche hath fully satisfied and paid the said Jacob Williams the sum of money
 thereby secured which the said Jacob Williams doth hereby acknowledge. Now this Indenture Witnesseth
 that for the consideration aforesaid as well as for the further consideration of one dollar and no part
 by the said John L Roche to the said Mills L Gray at and before the executing and delivery of the said
 presents the receipt whereof is hereby acknowledged by the said Mills L Gray with the consent and
 approbation of the said Jacob Williams signified by his being party to these presents and the said
 Jacob Williams have granted bargained and sold conveyed and released and by these presents do bargain
 and sell convey and release unto the said John L Roche all of the estate right title interest claim
