Witnesseth that the said Dixon Broadshaw and Sophia his wife for and in consideration of the sum of forty dollars of lawful money of this Commonwealth to them in hand paid at or before the enrolling and delivery of these presents the receipt whereof is hereby acknowledged, have bargained and sold and by these presents do and each of them doth bargain and sell unto the said Rette Broadshaw her certain certain heirs and assigns forever. One certain tract or parcel of land lying and being in the County of Southampton containing one acre more or less surveyed and as it was by the hand of Brittain Broadshaw Deceased and given by Joseph Broadshaw to Dixon Broadshaw will more fully appear, together with all the appurtenances belonging or in any wise appertaining to the premises hereby granted or intended to be granted and the reversions and reversion reserved and reserved and all services benefits and profits of said land and premises together with every part and parcel thereof with every of their rights claims & Interest relating to the same. To have and to hold the said land and other premises with every of their rights members and appurtenances unto the said Rette Broadshaw her heirs and assigns forever to and for the only proper use and behoof of her the said Rette Broadshaw her heirs and assigns forever, and the said Dixon Broadshaw and Sophia his wife doth hereby grant for themselves their heirs and every of them will warrant and forever defend the said tract or parcel of land and other premises and appurtenances before mentioned and every part and parcel thereof unto the said Rette Broadshaw her heirs or assigns forever against themselves or any other person or persons whomsoever claiming the same or any part or parcel thereof which right and title the said Dixon Broadshaw & Sophia his wife do hereby warrant and forever defend unto the said Rette Broadshaw her heirs and assigns forever.
