This Indenture made and entered into on this 5th day of October in the year of our Lord eighteen hundred
and thirty nine between Davis Barrett and Hannah his wife Benjamin Barrett and Sarah his wife all of the
County of Southampton and State of Virginia of the one part and John E Turner of the same County and state of
the other part witnesseth that the said Davis Barrett and Hannah his wife Benjamin Barrett and Sarah
his wife for and in consideration of the sum of One hundred and eleven dollars current money of this
Commonwealth to them in hand paid by the said John E Turner at or before the executing and delivery
of these presents the receipt whereof is hereby acknowledged have granted bargained sold alredy engrossed
and confirmed and by these presents do we each of them doth grant bargain sell alien enfranchise and
confirm unto him the said John E Turner his heirs and assigns forever one certain tract or lot of
land and premises situate lying and being in the aforesaid County of Southampton and parish
of Saint Lukes Containing by a late Survey Forty acres (to the same more or less) it being lot No. 3 in
the division of a tract of land of which Benjamin Turner senior did possesse and was divised by the
Commissioners appointed by a decree of the Court of this County for that purpose April 1835 and the
said lot No. 3 was drawn by said Davis and Benj: Barrett as will appear by reference to the
said Commissioners Report and bounded as follows (to west) Beginning at the centre of a black gum
and Maple standing in a small branch a corner for lot No. 3 Drawn by said John E Turner then
down the run of said branch to the run of box Swamp then down said swamp to the fork of
the Swamp thence up the run of the other prong of Swamp to said John E Turners line of
marked trees then along his line to a post a corner for lots No. 3 & 4 then along the dividing
line N 63° W 102 poles to the first station together with all right title interest claim or demand
of in and to the above described tract or lot of land and premises with its appurtenances thereto
belonging or in any wise appertaining. To have and to hold the aforesaid tract or lot of land and
premises with all and singular its appurtenances thereto belonging unto him the said John E
Turner his heirs and assigns forever (to and for the only purpose and behoof of him the said
John E Turner his heirs and assigns forever) and the said Davis Barrett and Hannah his wife and
Benjamin Barrett and Sarah his wife for themselves their heirs executors and administrators and
each of them doth hereby covenant and agree to and with the said John E Turner his heirs
executors and assigns that they will by these presents warrant and forever defend
the right and title of the aforesaid tract or lot of land and premises and every part or
parcel thereof against the claims or demands of all and every other person or persons
