This Indenture made the thirty first day of December in the year of our Lord one thousand eight hundred and thirty nine Between Mordecai Bradshaw and Amy his wife of the County of Southampton and State of Virginia of the One part and Abington Bradshaw of S. County and State of the other part. Witnesseth that the said Mordecai Bradshaw and Amy his wife in consideration of the sum of thirty five dollars of lawful money of the Commonwealth to them in hand paid or secured to be paid by the said Abington Bradshaw at or before the enclosing and delivery of these presents the receipt whereof is hereby acknowledged, have bargained and sold and by these presents do and each of them doth bargain and sell unto the said Abington Bradshaw his heirs and assigns a tract of land containing seven acres be the same more or less lying on the South side of the road leading from black water bridge to Vicks Red Tavern and bounded by the lands of Redd H Branch and Abington Bradshaw together with all ways waters and water courses profits Commodities the reversion and reversions remainder and remainders and profits thereof and every part and parcel thereof. To have and to hold the said seven acres of land with the Tenements and all and singular other the premises hereinafore mentioned & intended to be bargained and sold and every part and parcel thereof with every of their rights members and appurtenances unto the said Abington Bradshaw
