interest aforesaid which is due and owing to the said Barton Taylor as aforesaid or so much
thereof as may then be due and if any surplus thereupon remain in the hands of the said
William D Clarke the same shall be paid over by him to the said Richard Harris his heirs
executors, admors or assigns and in case the aforesaid debt shall be paid or before such time
and as aforesaid shall be made by the said Wm D Clarke shall return to him the said
Richard Harris all the title hereby transferred to him of in and to the above named land
and in case the said Wm D Clarke shall die before the full execution of this Trust
his executors or admors shall carry this Indenture into effect and operation and
the said Richard Harris for himself his heirs executors or admors hereby Covenant

AN Indenture made this 17th day of August 1840 between John A. Turner of the first
part Anthony Williams of the second part and John Ivy and James D Mathews of the third
part Whereas the said John A. Turner is justly indebted to the said John Ivy and James
D Mathews to the said John Ivy in the sum of two hundred and seventy one dollars
27/100 and to the said James D Mathews in the sum of three hundred and thirty two
dollars 22/100 due by bond executed to each bearing date the 17th day of August
1840 the payment whereof the said John A. Turner is desirous to secure: Now this Indenture
witnesseth that for and in consideration of the premises and for the further consideration
of one dollar in hand paid by the said Anthony Williams the receipt whereof is hereby acknowledged
by the said John A. Turner due by these presents grant bargain sell and convey
unto the said Anthony Williams his heirs and assigns the following negro slaves to wit Negro
woman Phoebe and her two children boy Tom and Dicks and Negro woman Phil
To have and to hold to him the said Anthony Williams his heirs and assigns forever
and the said John A. Turner for himself his heirs executors and administrators does
covenant with the said Anthony Williams his heirs and assigns that he the said John
A. Turner will and his heirs executors and administrators shall warrant and defend the
same to the said Anthony Williams his heirs and assigns forever against the lawful
Claims and demands of all persons whatsoever: Upon Trust nevertheless that the
