and promises To have and to hold the d<sup>e</sup> hereby granted or intended to be hereby granted tract or parcel  
of Land and promises with its appurtenances together with all the personal property hereby conveyed unto  
the said Shugars Lain trustee his heirs executors administrators and afyng forever to the only proprieuse  
and biship of him the said Shugars Lain trustee his heirs executors d<sup>r</sup> forever against all persons whatever  
shall and will warrant and defend by these presents. Upon trust nevertheless that the said Shugars Lain  
trustee his heirs executors and Admors shall permit the said Stephen H Washington to remain in quiet and  
peaceable possession of the said tract or parcel of Land and promises with its appurtenances together with  
all the personal property conveyed and take the profits there<sup>w</sup> to his own until default be made in the  
payment of the said sum of thirties hundred and thirties dollars and ninety five cents either in  
the whole or in part and ther upon this further trust that the trustee shall and will so soon after the  
happening of such default of payment as they may think proper or the said heires of Stephenson his heirs  
executors Admors or afyng shall resort to all the said tract or parcel of Land and promises with the  
appurtenances together with the personal property conveyed or such part of the hereby granted promises  
as the trustee is hereby authorized to set shall think sufficient for the purpose and shall think proper to  
set to the highest bidder for ready money at public auction after having fixed the time and place of  
sale at their own discretion and given ten days notice thereof and also notified the same by advertisement  
to be set up at the door of the Courthouse of Southampton County and some Court house previous to the day  
of sale and out of the money arising from such sale shall after satisfying the charges therof and all  
other expenses attending the premises pay to the said heires of Stephenson his heirs executors Admors  
or afyng the said sum of thirties hundred and thirties dollars and ninety five cents with interest  
which may theron lawfully have accrued and the balance if any shall pay to the said Stephen  
H Washington his heirs executors or afyng But if the whole of the <sup>d</sup> said sum of money be fully  
paid off and discharged to the said heires of Stephenson his heirs or afyng so that no default of  
payment of the said sum of money be made then this indenture to be void or else to remain in
