This Indenture made this 15th day of December in the year of our Lord one thousand eight hundred and Forty between Littleton R Edwards of the first part Edwards Bully Belmonte Rochelle Verniah Cobb William A Spake of the second part and Thomas R Jones of the third part whereas the said Thomas R Jones on the day of December 1833 in order to save harmless and indemnify the parties of the second part his securities to them several bondly executed from the said Thomas R Jones to Henry B Vaughan for the sum of one thousand dollars and by indenture of trust of that date convey to the said Littleton R Edwards his heirs & assigns the following property to wit A certain lot or piece of Land situate in and adjacent to the Town of Jerusalem and containing by Survey Seven and two third Acres of Land also all the household and Kitchen furniture of every description attached to appertaining or belonging to the Town of the said Thomas R Jones in the Town of Jerusalem aforesaid and all his the said Jones's other household and Kitchen furniture of every kind or description whatever. Also all his horses one Carriage and Harness one single gig and his stock of Cattle and Hogs and their increase. Upon trust for the use and purposes in said Indenture mentioned. And whereas since the execution of said deed of Trust the said Thomas R Jones hath released exoniated and discharged the said parties of the second part from any loss or damage which they might have sustained by virtue of their securityship which the parties of the second part doth hereby acknowledge. Now this Indenture witnesseth that for the consideration aforesaid as well as for the further consideration of one dollar in hand paid by the said Thomas R Jones at or before the making and delivery of these presents the receipt whereof is hereby acknowledged by the said Littleton R Edwards with the assent and approbation of the parties of the second part signified by his being a party to these presents and the said parties of the second part have granted bargain and sell remise release and confirmed and by these presents do grant bargain sell remise release and confirm unto the said Thomas R Jones all the whole right title claims interest and demand both at Law and equity which the said Littleton R Edwards has or holds in the property above described, To have and to hold the
