Articles of agreement made and entered into by Levi Mallow of the County of Southampton and state of Virginia and Jesse Cooper of said County and state. Now attended by these presents that whereas Jesse Cooper of the County of Southampton and state of Virginia hath this fifth day of December in the year of our Lord one thousand eight hundred and Forty by deed of Gift conveyed to Levi Mallow of said County and state a certain tract or parcel of Land situate in the County of Northampton in the state of North Carolina. Therefore witnesseth that the said Levi Mallow hath covenanted and agreed unto by these presents doth covenant and agree to and with the said Jesse Cooper to furnish him the said Jesse Cooper during his natural life a comfortable support and maintenance and for the faithful performance of this covenant on his part the said Levi Mallow for himself and his heirs (what is hereby understood and agreed and to afford said support in the event of the said Jesse Coopers surviving the said Levi Mallow) doth further covenant and agree that whereas hereafter the said Jesse Cooper shall complain of the support furnished him the Court of Southampton shall after hearing evidence on both sides direct in what way this covenant shall be kept and performed provided the Court shall be of opinion after the hearing of testimony as aforesaid that the said Levi Mallow has not kept his covenant according to the meaning and intent of this agreement and the said Cooper doth agree on his part to live in the family of the said Mallow unless the Court by reason of the failure of said Mallow to do his part shall otherwise order and direct.
