Witnesseth that the said Davy Lewis for and in consideration of the sum of Seventy four dollars & 22 cent which he justly owes to the said Willis Brashaw by note bearing date the Eighteenth day of January 1841, as also for and in consideration of the sum of one dollar to him in hand paid by the said James Clayton the receipt whereof the said Davy Lewis doth hereby acknowledge to the said James Clayton doth grant bargained sell and Convey and make over and by these presents fully hath granted bargained sold Conveyed and made over unto the said James Clayton his heirs and assigns forever two further lots of land and whereby four shillings and six pence per pound three Tolls there Chast two Spinnings whereby ten bushels crop of corn and for ever three bushels two plows three plow-hoes three weeding hoes two axes three pots one Dutch oven on pair wings two barrels of brandy one horse to have and to hold with all the right title and interest of him
