Witnesseth that and in consideration of the sum of thirty two dollars and fifty cents to him in hand paid by the said Sarah Hargrave the receipt whereof he acknowledges have granted and sold and by these presents with bargain & sell unto the said Sarah Hargrave and her heirs and assigns forever one certain tract or parcel of Land lying and being in the County of Southampton which said tract or parcel of Land is a part of the Land given unto the said Wm O Bailey by his Father and is bounded on the North by the lands of Sweet Branch and on the South and East by the lands of said Bailey containing by estimation four acres & three Acres & the same more or less. To have and to hold from me and my heirs forever the above granted premises with all and singular the appurtenances therunto belonging or in any wise appertaining to the only proper use and behoof of her the said Sarah Hargrave and her heirs and assigns forever and I do further Covenant and agree to and with the said Sarah Hargrave that I will defend unto her and her heirs the right title and interest of us and to the above granted premises free from the just demand of all persons whatsoever.
