This instrument made and entered into this 15<sup>th</sup> day of February in the year of our Lord eighteen  
 hundred and forty One by and between Emma Beale of the one part and Joseph A Edson of  
 the other part each of whom resides in the County of Prince George in the State of Virginia. Witness  
 that for and in consideration of the sum of two hundred dollars by the said Joseph A Edson to  
 her the said Emma Beale to enable her child Emma Beale  
 her the said Emma Beale to pay for a certain piece of Land lying and being in the County  
 of Southampton and supposed to contain about thirty acres which land she the said Emma  
 Beale delivered a bill to be paid in writing executed by Jacob Burns bearing date on the  
 15<sup>th</sup> day of February 1831 which deed was acknowledged by said Burns in the Clerks Office  
 before the Clerk of the Court of the County of Southampton on the same day of its date to be  
 recorded and in consideration of the above sum aforementioned the the said Emma Beale had  
 land demand granted and to form let and by these presents doth lease demise grant and to give  
 let unto the said Joseph A Edson all the above described land and promising the boundaries of  
 which will fully appear by referring to the aforesaid deed, with the appurtenances thereto belong-  
 ing. To have and to hold the said thirty acres of Land be the same Owner or Lessee and  
 her the said Joseph A Edson for and during and unto the full end and Term of his own  
 natural life at which time this lease is fully completed and ended paying therefor yearly  
 and every year during the said Term the lawful Tres of said Land and furthermore that  
 he the said Joseph A Edson shall and will at his own proper Costs and Charges well and  
 sufficiently repair and mend the same and keep and repair the said Term and the parts thereof  
 of the same belonging during his own natural life as aforesaid (Accruing by fire or the ad-  
 of God excepted) and the said Joseph A Edson and his part promising and hereby binds  
 himself his heirs Executors and Administrators to perform the Covenants and agreements herein  
 before mentioned or contained and which and his part shall be done and performed upon  
 which consideration he the said Joseph A Edson shall peaceably and quietly hold  
 occupy possess and enjoy the said premises hereby leased with the appurtenances  
 during his own natural life hereby granted as aforesaid without any molestation or  
 interruption whatsoever of or by her the said Emma Beale her heirs or assigns  
 or of or by any person or persons lawfully or equitably claiming or to claim from her  
 or under her name or any of them. And witness whereof they the said Emma  
 Beale and Joseph A Edson have hereunto set their hands and affixed  
 their seals the day and year first above written:
