Know all men by these presents that I Peter Faircloth of the Town of Durham in the State of Connecticut have made obtained and constituted and appointed and by these presents do make certain constitute and appoint Colman W Boring of the State of North Carolina and County of Northampton my true and lawful attorney for me and in my name to grant bargain and sell all that tract or parcel of Land lying and being in the County of Southampton and State of Virginia it being the same land devised to me by the last will and Testament of Sally Greenick dec^d with all the appurtenances thereto appertaining and all my whole right title and interest therein unto such person or persons and for such price or prices as he shall think proper and also for me and in my name and as my proper act and deed to sign seal deliver and acknowledge all such deed or deeds of conveyance as shall be necessary for the absolute granting and affixing of the premises unto the purchaser or purchasers in fee simple and for me and in my name to do all acts touching the premises necessary therein to be done for the lawful sale and transfer of the premises above mentioned Signed under my hand and seal this 15th day of July in the year 1820
