This Indenture made the 13th day of January in the year of Christ One thousand eight hundred and Forty One between Jesse Drury and Evelyn his wife of the County of Southampton of the one part and Harrison D Moore of said County of the other part Witnesseth that the said Jesse Drury and Evelyn his wife for and in consideration of the sum of three hundred and fifty dollars to him by the said Harrison D Moore paid the receipt whereof the said Jesse Drury doth hereby acknowledge hath granted bargained sold and conveyed and by these presents doth grant bargain sell and convey unto the said Harrison D Moore his heirs and assigns a certain tract or parcel of Land containing eighty five acres be the same more or less lying and being in the County of Southampton and bounded as follows (to wit) beginning at a Hickory tree (a corner in the road between said Drury Jeremiah Williford and Eliza Drake Thence a line of marked trees to a corner between said Moore and Drury Thence a line of marked trees to a corner in Poplar Swamp in Wallace and Jones line Thence down said swamp to a small top of poplar and the road a corner in Jones's line Thence up said road to the beginning. To have and to hold the said tract or parcel of Land with the appurtenances thereto belonging to him the said Harrison D Moore his heirs and assigns to the only proper use and behoof of the said Harrison D Moore his heirs and assigns forever and the said Jesse Drury for himself his heirs executors and administrators doth hereby Covenant and agree to and with the said Harrison D Moore and his heirs that he the said Jesse Drury and his heirs the said tract or parcel of Land with its appurtenances unto him the said Harrison D Moore against his heirs and against all persons whomsoever shall and will by these presents forever warrant and defend.
