Commissioners as aforesaid hath for and in Consideration of the sum of fifty dollars
dols to the highest bidder on a Credit of Three Months the said tract or parcel of
land whereof the said Mark A James hath become the purchaser of said land
containing by estimation eleven acres by the same more or less lying and being in the
county and state aforesaid and on the south side of the River Crook and bounded
as follows by the land of Nathan N Thomas and said Mark A James. To have and
to hold the said tract or parcel of land with all and singular the appurtenances
thereunto belonging or in any wise appertaining unto the said Doctor David Newson
and his heirs and assigns to the only proper use and behoof of him the said Mark
A James his heirs and assigns forever and we the said Howell Harris and Nathaniel
Francy Commissioners as aforesaid doth for ourselves as Commissioners our said
executors &c further covenant and agree with the said Mark A James this his exec-
tors and administrators and we the said Howell Harris and Nathaniel Francy Commissioners
aforesaid with the warrant and power aforesaid said land as far as is vested in us as
Commissioners unto the said Mark A James his heirs Executors and administrators against
the right title claim and interest of all and every other person or persons whatsoever
or money wherewith we the said Howell Harris and Nathaniel Francy Commissioners
aforesaid have been entailed or otherwise and affined over and above the sum and date first above written
