This Indenture made and entered into this 9th day of January in the year of our Lord One thousand eight hundred and forty One Between Jeremiah Fogner and Tempy his wife Thomas Drury and Parmelia his wife Patsy Griffin Patsy Drury and Elizabeth Drury of the one part and Joshua Horrod of the other part all of the County of Cumberland and State of Virginia, Witnesseth that the said Jeremiah Fogner and Tempy his wife Thomas Drury and Parmelia his wife Patsy Griffin Patsy Drury and Elizabeth Drury for and in consideration of the sum of Three hundred and twenty One dollars good and lawful Money to them in hand paid or secured to be paid by the said Joshua Horrod the receipt whereof is hereby acknowledged hath given granted and conveyed unto the said Joshua Horrod and his heirs and do by these presents give grant bargain sell make over and convey unto the said Joshua Horrod and his heirs forever One Certain Tract or parcel of Land lying and being in the County aforesaid and bounded as follows to wit Beginning at a white Oak a Corner in a Broadshaws ^{line} thence a line of marked trees to a ^{marked} corner in Jesse Cooks line thence a line of marked trees to a maple a corner tree in Dicks line containing by estimation One hundred and sixty acres be the same more or less and to hold unto the said Joshua Horrod the aforesaid Tract of Land containing One hundred and sixty acres be the same more or less with all of its improvements thereunto belonging unto the said Joshua Horrod his heirs and assigns forever to the only proper use and behoof of him the said Joshua Horrod and to his heirs and assigns forever. And the said Jeremiah Fogner and Tempy his wife Thomas Drury and Parmelia his wife Patsy Griffin Patsy Drury and Elizabeth Drury for themselves and their heirs executors and administrators with their consent and agree to and with the said Joshua Horrod his heirs and assigns that they the said Jeremiah Fogner Tempy his wife Thomas Drury and his wife Patsy Griffin Patsy Drury and Elizabeth Drury and their heirs the said Tract or parcel of land with appurtenances unto him the said Joshua Horrod his heirs and assigns against them the said Jeremiah Fogner Tempy his wife Thomas Drury and Parmelia his wife Patsy Griffin Patsy Drury and Elizabeth Drury and their heirs and assigns all persons whomsoever shall and will by these presents forever warrant and defend.
