That all men by these presents that Henry Robertson of Henderson County and State of Kentucky repairing special Trust and Confidence in Edwards Butts of the County of Southampton and State of Virginia have nominated Constituted and appointed and by these presents do nominate constitute and appoint the said Edwards Butts my lawful agent and attorney in fact and I do hereby invest the said Edwards Butts with full and complete power for me and in my name to collect and receive all Money or property coming to me in right of my wife Elizabeth C. Robertson (formerly Elizabeth C. Applwhite) and daughter of Mary Applwhite and Charlotte Applwhite his wife and I do hereby authorize and empower the said Edwards Butts to demand and for receive and receipt for all sums of Money or property for me and in my name in as full and ample manner as I could do were I personally present myself. In testimony whereof I have hereunto set my hand and affixed my seal this 21st day of June 1841.
