and appointment and do hereby make Constitute and appoint William H. Edmunds of the County  
and state aforesaid my true and lawful agent and attorney in fact for me and in my  
name and at my behalf but for my use and benefit to buy and sell also enfranchise  
and Convey a certain tract of land with its rights and appurtenances unto one Blazing  
and which is situate and lying in the state of Virginia and the County of Southampton  
the said Land having descended to me from my sister Elizabeth Eure deceased late of  
the County of Halifax and state of North Carolina the said Elizabeth Eure alias Elizabeth  
Edmunds having received the said Land in the division of the Estate of Samuel Edmunds  
deceased formerly of the County of Southampton and state of Virginia with full power to my  
said attorney to receive sue for demand and recover all sum of Money aforesaid to be  
paid for the purchase of said Land and receipts, acquisitions and Appurtenances  
therefor in my name and as my act to give make and deliver and also good and  
sufficient title deoily with all necessary Covenants and warranty unto the said Land  
thereby sold to sign and seal in my name and as my own proper act and done to  
deliver to the purchaser or purchasers and generally to act manage and do in and about  
the premises as fully and to the same extent as if I were personally present and  
I do hereby bind myself unto my heirs and declare that any and every act done and performed  
by my said attorney in virtue of these presents shall be ratified by me and binding to the  
same extent and effect as if done by me in my own proper person. In Testimony  
whereof I have hereunto set my hand and seal this 22<sup>nd</sup> day of November in the year  
one thousand and forty One.
