to Harrell Morrell of the one part Benjamin E Pope of the second part and Henry Kinard of the
Harrell Estate there and last part all of the County of Southampton and State of Virginia whereas the said
Harrell Morrell stands justly indebted to the said Henry Kinard in the sum of One hundred
Dollars Eighty three dollars and thirty eight cents appearing by bond of said debt herewith payable on
demand the payment of which together with interest which shall accrue thereon the said
Harrell Morrell are willing and desirous effectually to assure and secure to the said
Henry Kinard. Now therefore this Indenture witnesseth that the said Harrell Morrell
is well in consideration of the promise as of the sum of One dollar to him in hand paid
by the said Benjamin E Pope at and before the making and delivery of these presents the
full receipt whereof is hereby acknowledged and given which the said Benjamin E Pope and
all his legal representatives are forever released exonerated and discharged have granted
bargained and sold and do hereby grant bargain and sell unto the said Benjamin E
Pope that is to say that said Harrell Morrell have granted bargained and sold and do hereby grant bargain and sell
unto the said Benjamin E Pope his heirs and assigns
Pope his heirs and assigns all the Land Estate which be the said Harrell Morrell has any
interest in at this time lying and being in the County of Southampton and more especially the
tract of Land which be the said Harrell Morrell purchased of William L Rochelle to his own
part and Guardian for John B Rochelle which land is bounded by the lands of Master Pope
William Nelson John Bathard and the heirs of Richard B Day and Henry Joyner and
supposed to contain 81 3/4 Acres, the more or less, to him the said Benjamin E Pope his heirs
for him and them to have & to hold the said Interest in and the said Land described
aforesaid all and singular the appurtenances therunto belonging whatsoever of him the said
Harrell Morrell of the same to him the said Benjamin E Pope his heirs and assigns
forever. But Trust nevertheless that if the said Harrell Morrell his heirs or
assigns shall well and truly pay to the said Henry Kinard or any legal representatives the
aforesaid sum of One hundred eighty three dollars and 39^{cts} with the interest which shall
accrue thereon or or before the said Henry Kinard his heirs or assigns shall or may require the
same then this Indenture shall be void and of none effect but if the said Harrell
Morrell his heirs or assigns shall or may not pay the said sum of One hundred and eighty three
dollars and 39^{cts} with the interest then accrued thereon or or before the time the said Henry
Kinard his heirs or assigns may or shall require the same then upon request in writing
