To have and to hold the said hereby granted or intended to be hereby granted tract or parcel of Land and premises with its appurtenances unto the said Mr. Harrison his heirs Executors administrators or assigns forever. Upon Trust nevertheless the said William Harrison his heirs Executors administrators or assigns shall permit the said John A.
