It have and to hold to his proper use and behoof forever upon Trust with this proviso that the said Drury Bittle shall keep in quiet possession the said negro Jack and together with the said Ben & Pope shall be ordered by either party to sell or otherwise dispose off - Then the said Ben & Pope shall give reasonable and timely notice of the date of said negro or as much thereof as will satisfy the above named debt and out of the proceeds first pay the expenss thereof then pay the debt aforesaid and the balance ~~of~~ pay over to the said Drury Bittle or his legal representative and the said Drury Bittle covenant with the said Ben & Pope that he is possessed of an absolute right in the property above conveyed and that he will warrant and forever defend the same against himself and all other persons whatsoever - And Testimony whereof we and each of us have set our hands and seals the day and year before written -

This Indenture made this 9th day of April in the year 1822 between Ben Griffin and Eli Davis Comrs appointed by the County Court of Southampton to sell the tract of Land that Patsy Turner died seized of the one part and William Harris of the other part Witnesseth that the said Ben Griffin and Eli Davis as Comrs aforesaid in Consideration of the sum of Twenty five dollars of Lawful Money of this Commonwealth to them secured to be paid to the parties to whom the same is due at or before the executing and delivery of these presents the receipt whereof is hereby acknowledged have sold at public auction the tract of Land that Patsy Turner died seized and possessed of containing ^{about} twenty five acres be the same more or less and bounded as followeth. Beginning at a lightwood post in the Orchard there a straight line to gum in a branch there across the said Branch to a gum corner of Jesse Langford and the land known by the graven Land from a line to a black oak corner of Matthew Mills and William Harris there to be beginning together with all and singular the houses out houses outhouses buildings yards gardens ways roads water and watered courses profits Commodities emoluments hereditaments and appurtenances whatsoever to the said Land belonging with every part and parcel thereof - To have and to hold the said tract or parcel of Land with the appurtenances thereto belonging unto the said William Harris his heirs and assigns forever and the said Benjamin Griffin and Eli Davis as Comrs aforesaid for themselves their heirs the said Land unto the said William Harris his heirs and assigns forever free from the Claim or Claims of them the said Benjamin Griffin and Eli Davis as Comrs aforesaid and no further shall and will warrant their own right and title as Comrs and they warrant no other title than stated in these as Comrs aforesaid.
