Witnesseth that the said Samuel Revel for and in consideration of the sum of Sixty dollars Current Money of Virginia the receipt whereof the said Samuel Revel doth acknowledge himself fully and amply satisfied and paid hath granted bargained sold aliened enfeoffed and confirmed and by these presents doth grant bargain and sell unto the said Matthew Vick One Certain tract or parcel of Land and premises situate lying and being in the County of Southampton aforesaid and in the South side of Robinson River and in St. Luke's parish and bounded as follows to wit beginning at a poplar stump in the haw tree branch from thence down the Cypress swamp to the Bridge to the land of Benjamin Barnes Mill pond from thence up the Chapel Road Benjamin Revel and then line from thence to the beginning containing twenty acres be there more or less together with every thing belonging or appertaining to the said tract or parcel of Land.
