the sum of One hundred twenty dollars to be paid the twenty eighth day of December next 1832 as by a
bond bearing date on the same day now of fully paying and the said Willie A Morris in order to
secure and save himself the aforesaid William M^r do agree before the witness to convey the following
property to him all my interest in my present Corp of Corn fodder and pay my interest in the
School, & and teaching the present year and the proceeds of my Show bench together with all the
property formerly conveyed to Mr. Mark A Farnes. To have and to hold to the said Farnes J^r
McGlamore his agent Executrix or Administratrix upon express Condition annexed thereto (viz)
of the said Willie A Morris bid or before the 25th of December next 1832 pay the amount
