This Indenture made and entered into the 2nd day of August Am. the sum of Eight
hundred and forty two between James D. Maysburg of the first part and Benjamin Cobb of
the second part. Whereas the said Benjamin Cobb on the 22^d day of December ^{in the year of} 1837 in order to
secure the payment of the sum of Am. hundred and twenty dollars due by specially to Stephen
Murray the 21st day of Decr. 1838 and the further sum of Am. hundred and twenty dollars due in
like manner by specially to the said Stephen Murray on the 25th Decr. 1839 and by deed of
Trust bearing date the 22^d day of Decr. 1839 convey to the said James D. Maysburg his heirs
Executors administrators or assigns the Trust of land whereon the said Benjamin Cobb now
owns upon Trust and for the purposes set forth in said Indenture mentioned and
whereas the said Stephen Murray has since died and the said James D. Maysburg
qualified as his Executor to his last will and Testament and whereas the said Ben^g
Cobb has since paid and satisfied unto the said James D. Maysburg as Executor
