County of the other part. Witnesseth that the said Joel Harris and Sally his wife for and in
consideration of the sum of twelve hundred and eighty eight dollars to them in hand paid
by the said Howell & Hearbrough the receipt whereof the said Joel Harris and Sally his wife
do hereby acknowledge hath granted bargain and sold and by these presents doth grant
grant bargain and sell unto the said Howell & Hearbrough One certain tract or parcel of land
lying being and situate in the County aforesaid containing two hundred and more more
more or less and bounded as follows to wit North by the lands of Eli
to Miller, South by the Hornet Swamp East by the lands of John McHamme and
West by the lands of the Estate of Rich^d P. Clements dec^d. To have and to hold the said
tract or parcel of land and premises with the appurtenances unto the said Howell & Hearbrough
his heirs and assigns and also all the right title and interest whatever of them the said
