The receipt whereof is hereby acknowledged by the said John W. Mosgrove that same granted bargained and sold and by these presents do give grant bargain and sell unto the said James McLemore his heirs Executors administrators and assigns forever the following property to wit. two horses two brass Cattle five goats two deer and furniture two racks two cows three two turning ploughs one buggy and contents two tables two chairs two pots one horse frying pan and two kettles two ovens one safe and contents two two ploughs of plough two one still and still around all my River Cocks crop of Corn Cotton and pasture three barrels brandy two spinning wheels one sewing loom one cart and wheels one shot gun one pair one iron one shovel and long pair steel iron spaded fork and one sewing hoop and garments ^{cut} hoop - To have and to hold the above mentioned property unto the said James McLemore his heirs Executors administrators and assigns forever upon trust nevertheless and upon this express condition that if the said John W. Mosgrove shall fail to make true and faithful payment of the above sum of seven one dollar and sixty eight cents and thirty two dollars and twenty five cents and the two debts wherein the said Alexander McLemore is bound as security for the said John W. Mosgrove to Robert W. Daniel and Thomas H. Peckly on or before the 25th day of December next and the interest and costs that may lawfully accrue thereon then in that case the said

contract at the request of the said Alex. McLemore shall after advertising the time and place of sale at least ten days previous thereto proceed to sell to the highest bidder for ready money the property herein before mentioned and out of the money arising from such sale shall after deducting the charges thereon and all other necessary and reasonable expenses attending such sale pay to the said Alexander McLemore his heirs Executors administrators and assigns the sum of money herein before mentioned with the interest which may lawfully accrue thereon and the balance if any pay to the said John W. Mosgrove his heirs Executors administrators or assigns but if the whole of the above named sum of money shall be fully paid off and discharged so that no default of payment be made on or before the 25th day of December next then in that case this Indenture to be void otherwise to remain in full force and virtue - For witness whereof the parties to this Indenture have hereunto set their hands and affixed their seals the day and year above written

This Indenture made this 24th day of June in the year of our Lord one thousand eight hundred and forty two between Bennett H. Whitfield Trustee of the first part William W. Butler the debtor of the second part and John Hargrave the creditor as security for Monroe Butler and said William W. Butler to Benjamin E. Pope of the third part all of the County of Southampton and State of Virginia - Whereas the said Monroe Butler and William W. Butler on the fifteenth day of May in the year of our Lord one thousand eight hundred and forty in order to secure the payment of the sum of seven hundred and thirty eight dollars and twenty five cents to the said Benjamin E. Pope or rather to indemnify said John Hargrave as security for the said debt did by Contract of trust of that date convey to the said Bennett H. Whitfield his heirs Executors of certain lands and plantations lying and being in the aforesaid County of Southampton and other property therein specified - Upon trust for the use and purpose in said Indenture mentioned - And whereas since the executing and delivery of the said deed
