and forty two dollars and fifty cents hath this day given granted bargained & sold and by these presents do give grant bargain & sell unto him the said Joe Cobb him his heirs & assigns One certain tract or parcel of land containing fifty seven acres be the same more or less it being the lot of land allotted to the said Mary Drury belonging to her father Joseph Drury's estate also our interest in Benjamin Drury's lot of forty acres adjoining as by reference to the first by the County Surveyor also all the right & title we have in the down lands of Joseph Drury deceased it being an undivided interest To have and to hold the said land and appurtenances unto him the said Joe Cobb him his heirs & assigns forever free from the claim of all & every person or persons whatsoever and the said James Drury & Mary his wife will further warrant and defend the right & title of said lands & the interest in the said Joseph Drury's deceased lands unto the said Joe Cobb him his heirs & assigns forever In witness whereof we have hereunto set our hands & seals the day & date written.

This Indenture made this twenty sixth day of September in the Year 1842 between James & Joe Williams of the County of Southampton and State of Virginia of the one part and Matthew Williams of the County and State aforesaid of the other part Witnesseth that the said James & Joe for and in Consideration of the sum of Three hundred and fifty dollars Current money to him in hand paid by the said Matthew Williams at and before the sealing and delivering of these presents the receipt whereof he doth hereby acknowledge, he has granted bargained and sold and by these doth grant bargain and sell alioe release convey and confirm unto the said Matthew Williams his heirs and assigns All of my Land lying and being in the said County consisting of two tracts the one containing thirty acres more or less situated on the South side of the quarter Road & bounded as followeth beginning at a small branch at the road the Southeast Corner then up the branch to a Sweet gum, thence a straight line to a pine, a corner in Ferniehill Chaffell and Samuel Kello, thence along a line of marked trees to a Pine a corner of Samuel Kello's thence along to a White Oak a corner in Arington Gardner's line thence along a line of marked trees to a Red Oak a new shaped tree on the road thence down the road to the beginning The other tract containing 78 1/2 acres more or less known as the Lone tract, and bounded as followeth beginning in black oak now at the mouth of Cain's Branch thence up the branch to a black oak, thence along to a maple a corner in William Davis' line in the head of the big branch, thence down the big branch to the said black oak now (the mill pond) thence up the run to the beginning the said Matthew Williams his heirs and assigns to have and to hold the said tenement to act or parcel
