This Indenture made this the 15<sup>th</sup> day of August in the year of our Lord one thousand eight  
hundred & forty two between John Moore of the first part, Thomas I. Brutton of the second part and the  
Brother of the third party. Whereas the said John Moore doth justly indebted to the said Thomas Brutton  
in the sum of five hundred & sixty seven dollars and Sixty six cents by bond due the 18<sup>th</sup> day of May  
last on demand which debt the said John Moore is willing & desirous to secure.

Now this Indenture witnesseth that for and in consideration of the premises and also the further sum of  
one dollar in hand paid by the said Thomas I. Brutton to the said John Moore at and before the  
sealing and delivery of these presents the receipt whereof is hereby acknowledged by the said John Moore  
hath granted, bargained and sold & by these presents grant, bargain & sell, deliver & confirm to the said  
Thomas I. Brutton his heirs & assigns forever all that tract or parcel of land lying in the County of Southampton  
and State of Virginia containing one hundred and seventeen acres being the same more or less and bounded  
by the established lines & bounds as mentioned in the deed from Carr Bowens to Asael Joyner & also  
the deed from Jose Landford (who was trustee to Asael Joyner for Carr Bowens) to John Moore is also  
affixed by reference to the said deed all of which are on record in the Clerks Office of the County of South-  
ampton with all and singular the appurtenances also a negro girl Amancy about fourteen years  
of age to have and to hold the said hereby granted tract of land and premises with its appurtenances  
and negro girl Amancy unto the said Thomas I. Brutton his heirs and assigns forever, and the said John  
Moore for himself his heirs executors and administrators doth hereby covenant & agree to & with the said  
Thomas I. Brutton his heirs and executors administrors & assigns forever by manner and form following that is to  
say that the said John Moore his heirs &c the aforesaid tract or parcel of land and premises with the  
said Thomas I. Brutton his heirs &c against all persons whatsoever will warrant and defend from these  
presentes upon trust nevertheless that the said Thomas I. Brutton his heirs and assigns shall furnish the said  
John Moore to remain in quiet possession of the said tract of land premises & negro girl Amancy &  
take the profits thereof to his own use until default be made in payment of the said sum of five hundred  
and sixty seven dollars and sixty six cents either in the whole or in part and thereupon this further  
trust that the said Thomas I. Brutton his heirs executors administrors & assigns shall and will do soon after the  
happening of such default of payment as he or his representative may think proper or the said  
Thomas I. Brutton his heirs executors administrors & assigns shall request sell the said tract of land and  
negro girl Amancy to the highest bidder for ready money at public auction after having fixed the  
time & place of sale & given twenty days notice of time and place of sale by advertisement to be set up  
at the door of the Courthouse of the said County on some court day previous to the day of sale
