This Indenture made this 2d<sup>nd</sup> day of September in the year of our Lord 1842 between Thos. S. White (the debtor) of the first part William H. Griffen (trustee) of the second part Goodwin G. Griffen (the creditor) of the third part Whereas the said Thomas S. White is justly indebted unto the said Goodwin G. Griffen in the sum of one hundred & ninety nine dollars and seventy eight cents, due by bond bearing date with these presents, which more fully appears, which debt with legal interest thereon the said Thomas S. White is willing and desirous to secure. Now this Indenture witnesseth that for and in consideration of the premises and also for the further consideration of one dollar of lawful money of Virginia to the said Thomas S. White in hand paid by the said William H. Griffen at or before the sealing and delivery of these presents the receipt whereof is hereby acknowledged, he the said Thomas S. White hath given, granted bargained and sold, and by these presents doth give, grant, bargain & sell unto the said William H. Griffen his heirs and assigns forever all my right and title in a certain tract or parcel of land lying and being in the County of Southampton in the State of Virginia containing two hundred & twenty four & half acres to the sum more or less and bounded as follows viz on the east by Black water river, on the north by Jordan Johnson and Allen Edwards, on the West and south by Nathan Lester & Samuel Cobbs for reference being had thereto it will fully appear with all and singular the appurtenances pertaining thereto. To have and to hold the said hereby granted or intended to be hereby granted tract or parcel of land and premises with every of the appurtenances unto the said William H. Griffen his heirs, executors, administrators & assigns in trust forever, and the said Thomas S. White for himself his heirs executors & assigns doth hereby covenant promise and agree to and with the said William H. Griffen his heirs executors & assigns power in manner and form following, that is to say that the said Thomas S. White his heirs executors & assigns the aforesaid tract or parcel of land hereby conveyed unto the said William H. Griffen his heirs executors & assigns and assigns against all persons whatsoever, shall and will warrant and garnish defend by these presents upon trust nevertheless that the said H. Griffen shall furnish the said Thomas S. White to run him in payment of the said tract or parcel of land until default be made in the payment of the said sum of money above mentioned with legal interest thereon in whole or in part and then upon this further trust that the said H. Griffen or his heirs executors & assigns shall and will do good after the happening of such
