THIS INDENTURE made this 28th day of October one thousand eight hundred & forty two,
by and between Joshua Joyner and Sally Joyner his wife of the County of Southampton and State of
Virginia of the first part and Carr Bowers of the County and State aforesaid of the second part and James
Holmes of the same County & State of the third part Witnesse, that whereas Joshua Joyner & Sally
his wife stands justly indebted to Carr Bowers by note duly executed bearing equal date with these presents
for the just and full sum of Fifty four dollars and eighteen cents and whereas the said Joshua Joyner and
Sally his wife is willing and desirous to indemnify and secure the debt hereby incurred to the said Carr
Bowers. Now therefore the said Joshua Joyner and Sally his wife for and in consideration of the premises &
for the further Consideration of one dollar to them in hand paid by the said James Holmes at and before
the ending and delivering of these presents they the said Joshua Joyner and Sally his wife hath granted
bargained sold & delivered and confirmed, and by these presents for themselves their heirs Executors & Administrators
doth grant bargain sell and deliver unto him the said James Holmes & to his heirs and assigns a certain tract or
parcel of land lying and being in the County of Southampton called the Rose Tract containing one hundred acres
to the same more or less and bounded as follows (to wit) bounded on the East by David Carr & Carr Bowers
on the South by Bowers on the West by Mary Pittlow and on the North by James Joyner land, reference thereto
will more fully appear To have and to hold the said tract and parcel of land unto the said James Holmes his
heirs and assigns forever upon the following Trust, that is to say, that if the said Joshua Joyner and Sally
his wife shall neglect or fail to discharge the debt due Carr Bowers or any part of it or if they shall neglect
or fail to pay and discharge the note due Carr Bowers in his individual capacity by delay, that upon such
neglect and delay It shall be the duty of the said James Holmes immediately on his being thereto requested by
the said Carr Bowers his heirs Executors administrators or assigns after he shall have given at least twenty
days notice by advertising at four or five Publick places in the County the time and place of said sale, shall
proceed to sell for ready money to the highest bidder the said tract of land hereby conveyed, and pay all expen-
ses of carrying this present trust into execution as well as the debt above mentioned or so much thereof as shall
then remain unpaid with the ensuing interest thereon, and if any surplus shall remain after having thus
settled and paid off the above mentioned debt interest & cost in the hands of said trustee James Holmes
the same shall be paid unto the said Joshua Joyner and Sally Joyner his wife their heirs Executors &
Administrators and the said Joshua Joyner and his wife for themselves their heirs & assigns so and so ever
will defend the right and title of said land unto the said James Holmes his heirs and assigns from all
person whatever claiming or pretenting to claim said land. In witness whereof they and each of them
