Ms Indenture made and entered into this 19th day of November in the year of our Lord
One thousand eight hundred and forty two between Caswell Horrell and Jane Horrell his wife of the County
of Southampton and State of Virginia of the one part and Benjamin E. Pope of the same County & State
of the other part. Witnesseth that the said Caswell Horrell and Jane Horrell his wife for and in
consideration of the sum of Three Hundred and Two dollars to them in hand paid by the said Benjamin
E. Pope at or before the concluding and delivery of these presents the receipt whereof is hereby acknowledged
hath granted bargained sold and confirmed and by these presents doth grant bargain sell & confirm
unto him the said Benjamin E. Pope his heirs and assigns forever one certain tract or parcel of land
lying and being in the aforesaid County of Southampton. Containing by late survey one hundred
and fifty one acres be the same more or less adjoining the lands of Hartwell Horrell Sally Day
Sally Pope John Barham & others and being the same tract of land the said Caswell Horrell
purchased of William L. & John R. Rochelle. Together with all the right title interest claim or
demands of in and to the above described tract or parcel of land and premises with its appurtenances thereto belonging or in anywise appertaining to have and to hold the aforesaid tract
or parcel of land and premises with all and singular its appurtenances thereto belonging unto
him the said Benjamin E. Pope his heirs and assigns forever to and for the only proper use and
service of him the said Benjamin E. Pope his heirs and assigns forever and the said Caswell
Horrell and Jane his wife for themselves their heirs executors & administrators doth hereby command
and agree to and with the said Benjamin E. Pope his heirs executors and assigns that they will
by these presents warrant and forever defend the right and title of the aforesaid tract or parcel
of land and premises and every part or parcel thereof against the claims or demands of all and
every person or persons whatsoever. In witness whereof the said Caswell Horrell & Jane Horrell his
wife have hereunto set their hands and affixed their seals the day and year first before written.
