Virginia (Wtngfleth) that whereas the said Septah Darden being willing and desirous to
 secure and save harmly the said Nathaniel T Williams his security from the payment
 of a bnd due to Nathaniel Francis of the sum of five hundred and ninetyn dollars
 and seventy cts. bearing equal date with these presents and for the further consideration
 of the sum of one dollar to him in hand paid by the said John M Gurley at and before the
 concluding and delivery of these presents, hath granted, bargained & conveyed, and by these
 presents doth grant bargain & convey unto the said John M Gurley Upon Trust the fol-
 lowing property to wit. One hundred and ninety acres of land lying and being in County of South-
 ampton and bounded by the lands of Harrell Whitehead & others, two head of horses, ten head
 of cattle, stock of hogs & sheep, household and kitchen furniture or wares still remaining
 biler two carts & wheels, furnishing utensils &c. To have and to hold the aforesaid property
 unto him the said John M Gurley, (Himself) if the said Septah Darden his heirs or
 assigns shall well and truly pay unto the said Francis his debt and interest and save hon-
 orably the aforesaid Nathaniel T Williams his security as aforesaid then in that case the said
 shall shall be void and of no effect but if the said Septah Darden his heirs assigns
 shall fail and refuse to pay the aforesaid debt and interest, when he shall be demanded by him
 the said Francis. Then in that case as in like cases it shall be the duty of him the said
 John M Gurley who was mutually chosen by the parties as trustee to advertise the aforesaid
 land and other property after giving legal notice of the time and place of sale sell with the highest
 bidder for such or so much thereof as will be sufficient to pay and satisfy the aforesaid
 debt of five hundred and ninetyn dollars and 79/100 cents after first paying all legal expenses
 that may accrue thereon and the surplus if any pay unto the said Septah Darden
 or his order. and it is further agreed by and between the parties that the aforesaid property
 Should remain in the hands and use of him the said Septah Darden till called for
 to save harmly the aforesaid Nathaniel T Williams his security as aforesaid agreeable
 to the tenor & meaning of this deed. In testimony whereof the parties to these presents have
