 gained ~~and~~ sold and do hereby grant, bargain and sell unto the said Bennet Barrett
 his heirs ~~and~~ assigns one certain tract or parcel of land which he the said Benjamin Phillips
 now owns lying ~~and~~ being in the County of Southampton and bounded by the lands of Wm.
 Day and on the South, Wm. Drake's Sally Ford on the west; Jacob Barnes on the North
 and the town of Muncy Magd on the East? Containing by estimation 186 acres to the same
 more or less. Also the following named property to wit 2 horses 4 cows & Sheep 9 head of hogs
 1 Cart wheels 1 gig carriage 1 apple mill 2 cedar trees 23 cedar barrels 2 plowshares 3 ploughs
 3 carters 3 wood boxes 2 gun boxes 3 acres 1 grained stone 2 rawhides 20 barrels corn 2000 bushels 1500
