 the receipt whereof is hereby acknowledged hath granted bargained and sold and by these pres-  
 ents doth grant bargain and sell alien enfeoff and forever confirm unto him the said Joel  
 Vick a certain tract or parcel of land situate lying and being in the County aforesaid  
 containing forty two acres more or less bounded by the lands of Selah Ellsworth on the North  
 East and South side and on the West by Caswell Worrell. To have and to hold the within  
 bargained premises together with all houses orchards to have and to hold the said tract of land  
 and every part or parcel thereof unto him the said Joel Vick his heirs and assigns forever and  
 the said Willis E Beale for himself his heirs and assigns the said tract of land with all its  
 appurtenances unto the said Joel Vick his heirs and assigns forever free from the claims of all  
 and every person persons whatsoever whatsoever will warrant and forever defend to him the said  
 Joel Vick his heirs and assigns free from all claims of all and every person persons whatsoever

 the first day of January 1843 also by another bond for sixty dollars bearing date the 26<sup>th</sup>  
 day of December 1842 and whereas the said Francis is bound as his security to Samuel  
 & John Drury in the sum of seventy eight dollars & fifty seven cents due the 1<sup>st</sup> day of June  
 1841 to Edwin Harris executor of Elizabeth Harris in the sum of Eighty five dollars and  
 ninety cents due the 17<sup>th</sup> day of September 1840 subject to a credit of nineteen dollars
