Elisha Pope is willing and desirous to secure now this Indenture witnesseth that out in consideration of the sum of one dollar in hand paid careful money of Virginia to the said Elisha Pope by the said said Selah Ellsworth the trustee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged by the said Elisha Pope both given, granted, bargained and sold, aliened, exchanged, released and confirmed and by these presents, doth give grant, bargain sell alien enfeoff release and confirm to the said Selah Ellsworth his heirs and assigns forever the following Negroes or all his right and interest in the following Negroes and ~~and~~ other personal property To wit one negro man Dred, one woman Mary and one Charlotte. Two horses two head of cattle twenty one head of goats four feathered birds and furniture, three pair of Cart-wheels, two guns one bridle and no saddle one gun and harness, one brandy still, together with all the right interest in the ~~the~~ above negroes and personal property hereby granted to have and to hold the said here hereby granted Negroes and personal property as above mentioned property unto the said Selah Ellsworth the trustee his heirs Executors administrators and assigns forever and the said Elisha Pope for himself his heirs Executors and administrators doth hereby covenant promise and agree to and with the said Selah Ellsworth his heirs exec^ts adms^t and assigns forever that the aforesaid Negroes and personal property hereby conveyed unto the said Selah Ellsworth his heirs exec^ts and adms^t and assigns against all persons whatsoever shall and will warrant and defend by these presents upon trust reverently the said Selah Ellsworth his heirs executors and administrators shall permit the said Elisha Pope to remain in quiet possession of the said property hereby conveys until default be made in the payment of the above named bonds then the said Selah Ellsworth or his heirs Executors administrators or assigns shall and will so soon after the happening of such default of payment as they may think proper or the said Matthew V. R. his Executors administrators or assigns shall request sell all of the above said property or the interest hereby conveyed or such part as the trustee shall think sufficient to satisfy the ~~the~~ above bonds shall sell to the highest bidder for Cash at publick auction after having fixed the time and place of sale, and lawful notice by advertisement of the sale of the above conveyed property so that no default of payment be made then this Indenture be void or else to remain in full force and virtue In witness whereof the said parties to these presents have hereunto set their hands and affixed their seals the day and year first above written.
