Witnesseth the said Selah Ellsworth for and in consideration of the sum of Two hundred and six dollars paid to him in trust the receipt whereof is hereby acknowledged by the said Ellsworth hath granted and confirmed aliened and by these presents doth grant and confirm unto the said Matthew Vick all of his interest right and title as trustee to one certain tract of land wherein Elsie Pope now resides containing by estimation one hundred and ninety three and one third acres be the same more or less together with all of the improvements to have and to hold the above land, and premises unto the said Matthew Vick to him and his heirs forever and the said Selah Ellsworth for himself and his heirs and assigns executors and administrators doth grant to and with the said Matthew Vick his heirs and assigns forever defend all of his the said Selah Ellsworth right and title as trustee only against whatsoever claims may come against the said land and premises of and. This Indenture made the sixteenth day of July in the year of our Lord one thousand eight hundred and forty two between William S. Rochelle and John R. Rochelle of the one part and Cathbert D. Barham of the other part, witnesseth: That the said Wm. S. & John R. Rochelle in consideration of the sum of two hundred and thirty dollars of lawful money to them in hand paid by the said C. D. Barham at or before the executing and delivery of these presents, have granted, bargained and sold, and by these presents do, and each of them doth, bargain and sell unto the said C. D. Barham, his heirs, and assigns, their interest in a certain tract, or parcel of land lying and being in the County of Southampton and State of Virginia; and bounded by the lands of C. D. Barham, J. C. Rees, William Wilson, Weston Pope, Benj. S. Pope, J. Burton Taylor (and being three eights of the land held by Mary A. Kirby in her lifetime as her dower of John Days estate) which is claimed by Wm. S. and John R. Rochelle, under the will of Edmund Day deceased and their proportion of their mothers interest) together with all, and singular, the appurtenances, privileges, of every kind, and character, in the same, or intended to be sold, to the said C. D. Barham, to have, and to hold the above named interest in said land, with the tenements, hereditaments and all and singular other the premises herein before mentioned, or intended to be sold and every part thereof with every of their rights, & appurtenances, unto the said C. D. Barham, his heirs, & assigns forever, and the said Wm. S. and John R. Rochelle for themselves and their heirs, the said land with all, and singular the appurtenances before mentioned, unto the said C. D. Barham his heirs and assigns, free from the claim or claims of whom the said Wm. S. and John R. Rochelle, or either of them, or their or either of their heirs and if all and every person or persons, whatsoever shall will, and do, warrant and defend forever by these presents.
