to him in hand paid by the said Walter Myrick at and before the executing & delivery of
these presents the receipt whereof is hereby acknowledged hath bargained and sold and by
these presents doth grant bargain and sell unto the said Walter Myrick his heirs & assigns
all his interest right and title in and to the dower estate of his Grand mother Mary Barrett
widow of Jacob Barrett dec^d consisting of two hundred & twenty acres of land more or less
whereon she now lives & twenty one negroes now in her possession together with there increase his
interest being one eighteenth part thereof To have and to hold the said interest right & title
a one eighteenth part of the said dower land and negroes to him the said Walter Myrick
his heirs & Executors adm^r & assigns, and I the said James H. Barrett for myself my heirs & Ex^r
administrators to and will forever warrant and defend all the right and title in and to the said
interest or one eighteenth part of the said dower interest of the land and negroes of the said
Mary Barrett to him the said Walter Myrick his heirs & adm^r & assigns against the lawful claims
