This Indenture made this twenty third day of January in the year one thousand eight hundred and forty three between Joshua Snyder of the first part and James Williams of the second part Thomas Snyder, John Snyder and Elly Snyder of the third part Witnesseth that the said Joshua Snyder in order to secure a debt due from him to Thomas Snyder on one note bearing the same date for seventy five dollars and one to John Snyder the same date for seventy dollars and one to Elly Snyder the date for fifty dollars he the said Joshua Snyder hath bargained and by these presents doth bargain sell unto the said James Williams the following property to wit my house hold and kitchen furniture also my stock of cows containing six in number also my stock of hogs containing sixteen also my plantation now reside on containing by estimation six to two acres be the same more or less on condition that the said Joshua Snyder shall retain possession of the said property (and enjoy the same thing) until such time as he fails to make payments of the aforementioned debt and in default thereof upon this further conditions that the said James Williams shall sell the aforesaid property or so much as will be necessary for the payments of the said debt with interest thereon and the expenses of this trust at public auction for cash having given at least ten days notice of the time and place of sale by advertisement at several public places in the neighborhood.
