Almon B Hart of the first part, John Vick trustee of the second part and Joseph Davis executor of the third part all of the County of Southampton and State of W^{re} Metreple that the said Almon B Hart for and in consideration of the sum of one dollar to him in hand paid by the said John Vick at or before the making and delivery of these presents the receipt whereof is hereby acknowledged as well as the further consideration of the said Almon B Hart being justly indebted to the said Joseph Davis in the just and full sum of Eighty dollars due by bond which the said Almon B Hart is willing to secure the said Joseph Davis and which is the sole object of these presents hath granted bargained and sold and conveyed unto the said John Vick his heirs and assigns one certain tract of land lying and being in the County aforesaid containing one hundred acres be the same more or less and bounded as follows met by Allen Stephenson land on the N^o East by Penoch Branches land on the South by Margaret Harts land of Seacrest Swamp. I convey unto the said John Vick his heirs or assigns for ever let after this special trust and condition that the said John Vick his heirs or assigns upon being requested by the said Joseph Davis his heirs or assigns shall make sale of the above mentioned land at publick sale for the best price that can be obtained any time after the 25th day of December 1842 after advertising the said land ten days at the most publick places in the neighborhood previous to the day of sale and with the money arising from said sale first pay to the said Joseph Davis his heirs or assigns his debt and all costs which may accrue in making said sales and then pay unto the said Almon B Hart the overplus if any and the said Almon B Hart for himself his heirs and assigns do warrant and defend the title and title of said land to the said John Vick his heirs and assigns for the purpose aforesaid do warrant and forever defend against any lawful claim or claim whatsoever and the said John Vick for himself his heirs and assigns or assigns do agree to make sale of the above mentioned land any time when required by the said Joseph Davis his heirs and assigns in testimony whereof I set my hand and affixed my seal this above date
