This Indenture, made this 1<sup>st</sup> day of March in the year of our Lord Eighteen hundred and forty three, Between Benjamin Hart of the County of Southampton of the first part, Joshua Hart of the County of Surry of the second part, and Benjamin & Drew of the County of Southampton of the third part and all of the State of Va, Whereas the said Benjamin Hart is justly indebted to the said Benjamin & Drew in the sum of two hundred dollars due this day as more fully appears by referring to a bond bearing even date with this Indenture, which debt with the legal interest thereon accruing to the said Benjamin Hart is willing and desirous to secure:

Now this Indenture witnesseth, that for and in consideration of the premises, and also for the further consideration of one dollar of lawful money of Virginia to the said Benjamin Hart in hand paid by the said Joshua Hart at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged by the said Benjamin Hart, hath given, granted, bargained, sold, aliened, enfeoffed, released and confirmed and by these presents doth give, grant, bargain, sell, alien, enfeoff, release and confirm to the said Joshua Hart, his heirs and assigns forever all that tract or parcel of land which he the said Benjamin Hart at the time lives or resides on, containing one hundred and thirty five acres, be the same more or less, lying and being in the County of Southampton in the State of Virginia, and bounded in the following manner to wit: on the west by the lands belonging to Charles Hart and Slack Swamp, on the south by the lands belonging to the said Benjamin & Drew known by the name of Richard Hart's place; on the East by said Drew's land place and on the North by said Drew's home plantation & being all the lands he the said Benjamin Hart owns or claims title to in the County of Southampton, with all and singular the appurtenances to the said tract or parcel of land belonging or in any wise appertaining, and all the estate, right title and interest of the said Benjamin Hart in and to the said granted or intended to be truly granted tract or parcel of land (and premises), To have and to hold the said truly granted or intended to be truly granted tract or parcel of land and premises, with its appurtenances, unto the said Joshua Hart, his heirs, Executors, administrators and assigns forever, Upon trust, nevertheless that the said Joshua Hart, his heirs, Executors, administrators and assigns, may and
