

Southampton and State of Virginia. Whereas George A. McNewson and John W. Rochelle have been the said Lemuel P. NOW This Indenture witnesseth that the said Lemuel P. Nicholson for and in consideration of the premises, as well as for the further consideration of one dollar to him in hand paid by the said Edm. D. Nash at or before the executing or delivery of these presents, the receipt whereof is hereby acknowledged by the said Nicholson has granted, bargained and sold, and does by these presents grant bargain and sell unto the said Edm. D. Nash his heirs or assigns forever, two certain brown mares which he purchased of the said John Jones. To have and to hold the aforesaid mares unto him the said Trustee. Upon Trust, Nevertheless that if he the said Nicholson shall pay and satisfy the said bond as aforesaid when it becomes payable so that no default of pay must be made; otherwise he the said Edm. D. Nash shall so soon after the happening of such default of payment be made when directed by the said Newson or Rochelle, expose at public sale to the highest bidder for Cash the above named personal property as aforesaid; after giving in the time and place and giving reasonable public notice thereof; and from the monies arising from such sale first pay all expenses attending such sale and the conveyance, secondly pay and satisfy the bond as aforesaid, and the surplus of any pay over to the said Lemuel P. Depe all the lot or parcel of land which he or she may be set apart to her the said Martha Whitfield out of the lands
