This Indenture made this 4<sup>th</sup> day of March in the year of our said  
Christ One thousand eight hundred and forty three Between Allen Edwards  
of the one part; and Thomas Worster of the other part, both of the County of South-  
ampton and State of Virginia (Witnesseth) that the said Allen Edwards for and  
in consideration of the sum of one hundred and sixty five dollars current money  
of Virginia to him in hand paid by the said Thomas Worster the receipt whereof  
the said Allen Edwards doth acknowledge himself fully and amply satisfied  
and paid hath granted bargained, sold aliened, enfeoffed and confirmed and by  
these presents doth grant bargain and sell unto the said Thomas Worster to him  
and his heirs forever, one certain tract or parcel of land and premises situate lying  
and being in the County and State aforesaid, containing by estimation one hun-  
dred and six acres be the same more or less and bounded as follows (to wit)  
Beginning at a white oak a cr. of Bennetts land thence along his line of mar-  
kets to a dead pine a cr. of Holdens thence along his line to a pine cr. of Har-  
dicks R. Brants thence along his line of marked trees to a black gum in Sarah  
branch thence up the run of said branch to the first station, Together with all houses  
out houses edifices buildings, yards Gardens Orchards, ways waters and water courses  
whatsoever belonging, or in any wise appertaining to the said tract or parcel of land  
to have and to hold the same unto the said Thomas Worster to him and to his heirs  
forever And the said Allen Edwards for himself his heirs Executors Administrators  
and assigns doth by these presents covenant, and grant to and with the said Thomas  
Worster his heirs and assigns, that he will by these presents, covenant and favor defend  
all right title claim or demand, of any person, or persons, claiming or demanding the  
same; or any part or parcel thereof. In Witness whereof the said Allen Edwards  
has hereunto set his hand and affixed his seal this day and date first above written.

This Indenture made this 15<sup>th</sup> day of April 1843 between Mary  
Drake of the first part Sethus Charles trustee of the second part and Eli Drake  
of the third part, all of the County of Southampton and State of Virginia. Witness that  
the said Mary Drake for and in consideration of the sum of one dollar to her in hand paid  
by the said Sethus Charles, at or before the executing or delivering of these presents, the  
receipt whereof is hereby acknowledged as well as the further consideration of the said  
Mary Drake being justly indebted unto the said Eli Drake, in the just & full sum  
of seventy five dollars due by bond bearing date the 25<sup>th</sup> day of December 1840, and  
the same to be binding for all bonds or accounts which may be justly due the said  
Eli Drake when we settle or when he is paid of from the said of the said property  
in good money with lawful interest thereon witness that the said Mary Drake is  
willing to secure the said Eli Drake which is her sole object of these presents hath
