This Indenture made this 4th day of March in the year of our Lord Christ One thousand eight hundred and forty three Between Allen Edwards of the one part and Thomas J Brister of the other part, both of the County of Southampton and State of Virginia (Witnesseth) that the said Allen Edwards for and in consideration of the sum of one hundred and sixty five dollars current money of Virginia to him in hand paid by the said Thomas J Brister the receipt whereof the said Allen Edwards doth acknowledge himself fully and amply satisfied and paid hath granted bargained sold aliened, enfeoffed and confirmed and by these presents doth grant bargain and sell unto the said Thomas J Brister to him and his heirs forever, one certain tract or parcel of land and premises situate lying and being in the County and State aforesaid, Containing by estimation one hundred and six acres be the same more or less and bounded as follows (to wit) Beginning at a white oak a cr. of Bennetts land thence along his line of marsh to a dead pine a cr. of Holdens thence along his line to a pine cr. of Harmons Duke R. Bransb's thence along his line of marsh to a black gum in Sarahs branch thence up the run of said branch to the first station, Together with all houses out houses edifices buildings, yards Gardens Orchards, ways waters and water courses whatsoever belonging or in any wise appertaining to the said tract or parcel of land to have and to hold the same unto the said Thomas J Brister to him and to his heirs forever And the said Allen Edwards for himself his heirs Executors Administrators and assigns doth by these presents covenant and grant to and with the said Thomas J Brister his heirs and assigns that he will by these presents, covenant and forever defend all right title claim or demand, of any person or persons, claiming or demanding the same; or any part or parcel thereof. This Indenture made this 15th day of April 1843 between Mary Drake of the first part Sethus Charles trustee of the second part and Eli Drake of the third part all of the County of Southampton and State of Virginia. Witnesseth that the said Mary Drake for and in consideration of the sum of one dollar to her in hand paid by the said Sethus Charles at or before the sealing or delivering of these presents, the receipt whereof is hereby acknowledged as well as the further consideration of the said Mary Drake being justly indebted unto the said Eli Drake, in the just & full sum of seventy five dollars due by bond bearing date the 25th day of December 1840, and the same to be binding for all bonds or accounts which may be justly due the said Eli Drake when he settle or when he is paid of from the said Mary Drake is in good money with lawful interest thereon witnesseth that the said Mary Drake is willing to secure the said Eli Drake which is her sole object of these presents hath
