This Indenture made and entered into this 12th day of May 1843 between
James C Taylor of the one part, John M Guley of the other part, Witnesseth that
the said James C Taylor in order to secure the payment of the following debts to wit,
a bond due Frederick Taylor, on demand February 3/1842 for the sum of four hun-
-dred and twenty dollars, one other bond due the same for the sum of two hundred & thirty
dollars, on demand May 10/1843, and for the further sum of about the only due the same
by account; also an acceptor's order drawn by David Newson in favor of Saml
son & Co with interest thereon from the 25th day of December 1842 for the sum
of twenty six dollars also a debt due Patterson, Mills & Co, by bond due 1842 for about
fifteen dollars, also an account due Patterson & Mills for about twenty dollars, and
in consideration of the sum of one dollar to him in hand paid by the said John
M Guley at or before the engraving and delivery of these presents the receipt-
whereof is hereby acknowledged, he the said James C Taylor hath granted, bar-
gained, and sold and by these presents doth grant bargain and sell unto the said
John M Guley, the following slaves namely, negro man Jack, Woman Chassy,
girl Gardine and boy Anthony, and the future increase of the said female slaves
Also 1 mule, one horse, 10 head of cattle and their increase 20 head of hogs and
their increase, 4 br Steads and increase, 1 single gig and harness, 2 cart bodies,
and two fr cart wheels, 1.45 Gallon Stee, tub and worn, 40 cedar cutting my growing
crop of corn, fodder, pease, Cotton, potatoes and apples, after paying the rent of the
plantation on which I reside, and Kinchen Garg's proportion of said crop for his ser-
vices for cultivating the same, 4 feather Beds and furniture, 6 sitting chairs, 1
shot gun, 1 walnut Table, and two pine do. 1 spine saw, 1 right day metal clock
1 grind stone, paraf crockery ware, kins of shoes, kitchen furniture of every descrip-
tion, farming utensils of every description, all my present crop of corn say about 20
bushels, about 2000 lbs studs fodder, all my Bacon and lard now on hand. So
have and to hold the said slaves hereby granted, together with the other property
hereby granted or intended to be granted unto the said John M Guley, his heirs
executors, administrators and assigns forever; Upon Trust nevertheless, that the
said James C Taylor shall be permitted to keep quiet and peaceable possession
