To have And to hold the said 160 acres of land to the said Allen Edwards his heirs and assigns forever, to the proper use and behoof of him the said Allen Edwards his heirs and assigns forever. And the said Copeland Turner for himself and his heirs executors and administrators, the above mentioned 160 acres of land unto the said Allen Edwards his heirs and assigns, in as full and ample manner as was warranted by the said David Lewis by the deed of trust herein recited, do warrant the same to the said Allen Edwards against the claim or claims of him the said Copeland Turner and all persons claiming by or under him.
